

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.santacruzmountainreiki.com, and Jenna Monaco International, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Jenna Monaco International, LLC include www.santacruzmountainreiki.com, Santa Cruz Mountain Reiki, Jenna Monaco International, LLC and www.jennamonaco.com. The Santa Cruz Mountain Reiki website is a Reiki Energy Healing and Card Readings site. By using the Santa Cruz Mountain Reiki website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Santa Cruz Mountain Reiki may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Santa Cruz Mountain Reiki's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Santa Cruz Mountain Reiki collects and uses your personal information to operate and deliver the services you have requested.

Santa Cruz Mountain Reiki may also use your personally identifiable information to inform you of other products or services available from Santa Cruz Mountain Reiki and its affiliates.

Sharing Information with Third Parties

Santa Cruz Mountain Reiki does not sell, rent or lease its customer lists to third parties.

Santa Cruz Mountain Reiki may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All

such third parties are prohibited from using your personal information except to provide these services to Santa Cruz Mountain Reiki, and they are required to maintain the confidentiality of your information.

Santa Cruz Mountain Reiki may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Santa Cruz Mountain Reiki or the site; (b) protect and defend the rights or property of Santa Cruz Mountain Reiki; and/or (c) act under exigent circumstances to protect the personal safety of users of Santa Cruz Mountain Reiki, or the public.

Tracking User Behavior

Automatically Collected Information
